INVITATION TO BID

QUOTATION NOTICE


Cantonment Board Rawalpindi being procuring entity invites sealed bids (on prescribed Bidding Documents) accompanied by earnest money of (2% of total bid) in the shape of Demand Draft / Pay Order / Call Deposits / Bank Guarantee / Insurance Guarantee from any Scheduled Bank / Insurance Company (as per PPRA Rules) in favour of Executive Officer, Rawalpindi Cantonment on market item rate basis for non-schedule items as per “**Single Stage Two Envelope Procedure**” under Rule 36(b) of PPRA Rule 2004 (as amended upto date) having expertise in relevant field & GST registered contractor in relevant category for the year 2021-22 and also are on Active Taxpayers List of the Federal Board of Revenue for execution of following work: -

TERMS AND CONDITIONS:

- Bidding documents / Tender forms can be obtained on the cost of Rs.10,000/- on submission of applications from the date of publication of advertisement in newspapers / PPRA Website but not later than 02/03/2022.
- Bidding documents will be deposited in tender box (to be placed in front of office of the Asstt. Secretary, Rawalpindi Cantt Board, the Mall Rawalpindi Cantt) on 08/03/2022 till **1300 HRS.** Technical Bid will be opened on the same date at **1400 HRS.** in the presence of the bidders or their authorized agents.
- Financial bid of successful / qualified bidders will be opened after 10 days of the opening of technical bid.
- Tender Bidding documents containing Invitation to the bid / Tender Notice, Instructions to bidders, Form of Bid, Conditions of Contract Agreement, Specifications, Bill of Quantities and Bid evaluation criteria etc. can be obtained on any working day during office hours from the office of Cantonment Board Rawalpindi at The Mall Saddar Rawalpindi Cantt on or before closing date / time of tender bid. Price of bidding document as per Tender Notice (non-refundable). Tender Bidding document can be downloaded from CB Rawalpindi website <http://www.rcb.gov.pk>
- Tender will be issued those firms who have valid PEC registered certificate having appropriate category as described in bidding documents.
- The “**Technical Proposals / Bids**” of the firms / contractors will be evaluated in accordance with laid down evaluation criteria mentioned in bidding documents.

7. **The Financial Bids / Proposals** of only technically responsive bidders will be opened after evaluation of Technical Bids in the presence of bidders / their representatives (who may like to attend) in the office of the Cantonment Board Rawalpindi on the date & time to be notified later on whereas the Financial Bids of technically non-responsive bidders shall be returned unopened to the respective contactors.
8. In case if the lowest tendered rate is less than reasonable rates, the lowest bidder shall have to deposit standing security (refundable after successful completion of the work) @ 15 % of estimated cost in the shape of Call Deposit within 07 days. In case of failure the already deposited 2 % earnest money shall be forfeited and tender will be cancelled and shall be offered to 2nd lowest bidders as per rules.
9. The validity of Quotation rates shall be minimum upto 180 days as per PPRA /PEC Rules.
10. The Cantonment Board reserves the right of demanding the analysis of the quoted rates from concerned bidder, to check their responsibility and workability.
11. The quantum of work may vary as per PPRA Rules and lowest bidders shall be bound to execute the work on similar rates / Terms & Conditions.
12. Conditional / Incomplete Tenders / Quotation wherein necessary details are missing will not be accepted.
13. Work order will be issued subject to approval from Competent Authority.
14. Successful tender shall have to execute an agreement (at their own cost) on non-judicial stamp paper of appropriate value for faithful execution of the contract.
15. Rawalpindi Cantonment Board / Executive Officer reserves the right to accept or reject all tenders (prior to acceptance) as per PPRA's Rules No.33 (1) due to any reason thereof.
